

# What the '97 Grads Think about their MLIS Experience

Again this year, the School's placement survey included an open-ended invitation to graduates to provide us with feedback on how well the MLIS program had prepared them for a career in library and information services. They were also asked on this survey to assign a numerical grade to the quality of their educational experience. These graduates were students in the U of A's MLIS program from 1995-97 if they were full-time; part-time students would have started the program somewhat earlier.

All but one of the 24 respondents to the 1997 survey gave a grade assignment and 18 provided written comments, some quite extensive. The detailed commentaries that are attached were edited slightly to protect the identities of respondents.

Overall, the '97 graduates were very positive in their comments about the MLIS program, ranging from "excellent general preparation", "great program", "good comprehensive overview", and "overall good preparation", to "taught me to look at the big picture", "learned a lot about theory and 'higher' ideals", "theoretical underpinnings for good service more and more evident every day", and "theories and principles became second-nature". Others

were a little more qualified in their responses, suggesting that they felt "fairly well prepared" or that "most aspects were covered", had received a "satisfactory introduction to LIS", or found it "easy to find a job". The graduates' overall quantitative rating was a grade of 7.8 on the U of A's 9-point scale, ranging from 7 to 9 (nobody gave us a 6).

While most graduates' comments consisted of overall impressions, a few made references to specific courses, instructors, and related program aspects that they had found particularly useful. Most frequently mentioned were the practicum and the field placement in the advanced reference course (6 times) and computer related and technology courses including the Internet and online searching (6 times). Research and advanced research were mentioned twice, and mentioned once were indexing, distance learning courses, Dr. Dave Leonard's courses, lunch with a librarian, and partner's days.

Graduates also suggested a number of areas for program improvement:

- BI course (2 mentions)
- two practicums in the second year
- more information about acquisitions
- government documents in the regular session
- more hands-on technical experience/application
- departmental and library resources: lack of online databases, limited hours of U of A Library operation especially in intersession
- too focused on the Alberta library field
- not enough on finding alternative employment with LIS background
- more about job searching.

The comments by '97 graduates indicate that some of the School's recent program improvements have alleviated concerns expressed in last year's survey. One example is the fall 1995 introduction of a practicum option offered in both terms that, together with the opportunity for hands-on reference experience through LIS 525, addresses more satisfactorily the earlier concerns about work experience in the program.

Information technology is an area of even greater expansion in the MLIS program. While it is always difficult for the School to keep financial pace with advances in this area, three Internet and software courses have been offered for the last two or three years by other departments in the Faculty of Education, and these courses have always been

accepted for credit in the MLIS program. There is also Dr. Dennis Ward's advanced information technology course option for which basic Internet skills are a prerequisite.

Exposure to automation is also being achieved through continuous incorporation into other parts of the MLIS curriculum. Our commitment to enhanced technology options in the program is further underscored by the School's current search for a new full-time faculty member with teaching and research interests in the general area of information management.

I want to thank all of the '97 graduates who took the time to respond both to the placement survey itself and to the invitation to comment on their MLIS educational experience.

# Accreditation Review at SLIS Update

The School of Library and Information Studies is currently planning for the on-site visit of the MLIS Program Review Panel on March 22-23, 1999. The process leading up to that visit has been an interesting one and one that I have been pleased to be a part of. In the Fall of 1997, an Accreditation Steering Committee and working committees were established to create and vet the School's *Program Presentation* document. This document will serve as the main source of information for the Review Panel when they conduct their on-site visit in March. I was asked to join the Steering Committee because of my position as liaison between the School and the Library Association of Alberta.

The purpose of the *Program Presentation* is self-assessment of the MLIS Program's goals and objectives, resources, and strengths and limitations. This self-assessment document includes chapters on Mission, Goals and Objectives; Curriculum; Faculty; Students; Administration and Financial Support; and Physical Resources and Facilities. The faculty members of the School each chaired a working committee with membership consisting, variously, of adjunct professors, sessional instructors, full and part-time students, library

association representatives, alumni, employers, and members of the Faculties of Education and Graduate Studies and Research.

The Steering Committee and the SLIS School Council were called together on November 6, 1998 to review the draft *Program Presentation* document prepared by these working committees. Members were invited to critique one of the chapters prior to the joint meeting. I found the document interesting enough however, that I read nearly the whole thing!

At the meeting, small groups were formed to give closer examination to each chapter. When the groups reconvened, recommendations were made by each group for the final draft of the *Program Presentation*. These recommendations were minimal and it was generally agreed that the document was well written and clearly answered each of the COA "Standards". The final document (due in February, 1999) will serve as a draft strategic plan for the next three to five years of operation in the School of Library and Information Studies.

The process of arriving at the final draft of the Program Presentation should be important to every practitioner. I was amazed at the amount of work that went into completing the document. Each chapter was thoroughly covered and left little room for questions although we did make minor suggestions for clarity.

By participating in this exercise, I realized how much the School is evolving while continuing to meet the needs of its students. More technology courses have been added to the curriculum while the Lab continues to gain new upgraded equipment. The faculty are publishing books and articles, speaking at events and conferences, and applying for and receiving research grants at an unprecedented rate.

As alumni, we should be following the changes at SLIS and giving faculty members our encouragement, input, and financial support. This will help them to continue to provide improved courses and to keep abreast of employers' needs. Things are changing at SLIS; they are not the same as when we were in library school!

## SCHOOL OF LIBRARY AND INFORMATION STUDIES

Applications are invited for a tenure-track position in Information Management in the School of Library and Information Studies. The appointment will be at the Assistant Professor level with a minimum salary of \$45,000. The date of appointment will be July 1, 1999.

Candidates must demonstrate a strong commitment to research and should have a research agenda that will promote the School's multi-disciplinary focus on issues of information access and equity. Candidates considered will possess a doctorate, or be able to demonstrate the likelihood of early completion of one. A commitment to high quality teaching is essential. The major area of teaching will be information management including several of the following: information retrieval, indexing, electronic reference, database construction and design, library consortia (both technological and organizational aspects), electronic publishing, the Internet, multimedia, library automation, information policy, and management. Effective interpersonal skills for participation in an academic environment and an interest in student advising are also required. The successful candidate will supervise research at the master's and possibly doctoral levels.

The School is a small, collegial unit with an articulated vision for teaching, research, and service "understanding information: exploring issues, creating access, pursuing equity". As part of Canada's second largest university, the School benefits from a progressive research library and excellent computer facilities. The School also enjoys extensive connections with other units on campus and well-established relationships with the professional community.
