A related focus of Rural Economy's research mission is the pursuit of public involvement to ensure relevance and effectiveness in the discovery, application and dissemination of knowledge in our areas of focus.

Rural Economy's annual report is the basis of a periodic stock-taking of many activities and events during the preceding year. Our report includes a listing of our staff members and their major areas of teaching, research, and other responsibilities. An account of the research output of the staff of the Department is given by the listing of their publications in the previous year. Readers will also find summaries of research grants, involvement with international programs, and other indicators of research and outreach activities. This annual report also provides a means for us to communicate with our valued friends, within and outside the University of Alberta, about some of our achievements and plans. Rural Economy achieved many of the goals that we had set for year 2001. In that year we undertook a comprehensive review of undergraduate courses in agricultural economics, policy and business. This has been the basis for updating course offerings, changing them to reflect a more integrative focus on the resource, environmental and business dimensions of agricultural, food and forestry industries. Changes in course offerings also reflect the specializations of new staff members who have joined Rural Economy in the past few years. Some of the changes in course focus will come into play immediately; others will take effect in 2003, following the publication that year of new course names and descriptions in the University of Alberta Calendar.

We had many events to celebrate in 2001. Amongst the highlights, the excellence of Vic Adamowicz's research was recognized by the award of a Senior Canada Research Chair. As a consequence of this award, the Department is able to hire an additional resource/environmental economist. It is hoped that this position will be filled in the current year. The Department's Cooperative Chair program in Agricultural Marketing and Business was reinvigorated during the year by the Cooperative Program Chair-holder, Ellen Goddard. This program has contributed to research and has strengthened outreach and communications with agri-industry. The Department's research, industry and public outreach activities in areas of resource, environmental and forest economics have continued to be pursued in collaboration with industry and government linkages that have been reinforced through the Sustainable Forest Management Network.

As in previous years, we are pleased that it has been possible to provide enrichments to the educational and learning environment that Rural Economy can offer students through the excellent facilities of the Rural Economy Research Computing Lab and Rural Economy's Berg Reading Room. Both these facilities have benefited from staff members' success in competitive granting competitions, as well as from the generous donations to Rural Economy from its friends. The generosity of donors has also enabled numbers of Rural Economy students to benefit from travel to and participation in professional meetings throughout the year.

I wish to express my personal thanks to colleagues and friends of Rural Economy who have helped the Department to pursue its mission in the time that I have been Chair. After two terms--ten years--it is time for a new Chair to take over. Ellen Goddard will have the responsibility to lead the Department from July 1, 2002. I know that she will enjoy the support of colleagues and friends of Rural Economy in her new role as Acting Chair of this Department in the coming year.

#### **Overview of the Cooperative Program in Agricultural Marketing and Business**

The Department of Rural Economy's Cooperative Program in Agricultural Marketing and Business was created through industry funding in the late 1980's. The broad purposes of the program are to conduct research, extension and teaching in the areas of agricultural marketing and business. The focus is on issues related to group activities, for cooperatives or other organizations. At the current time cooperatives in Western Canada are at a significant crossroads, as two of the biggest players have become private firms in the past 12 months. For the first time in Canadian history the cooperative stake is significantly less than 50% of the dairy processing and grain handling industries. Almost all agricultural cooperatives are struggling with issues relative to capital investment to expand or adopt new technologies, as well as questions of governance. Thus there is a large range of projects of interest to this program.

In addition to supporting the position of the Chair-holder, Dr. Ellen Goddard, the Cooperative program is funding graduate student research in agricultural marketing and business. Currently three Masters students and one PhD student are being funded through the program. Their research topics are

A project on the potential use of the New Generation Cooperative model by organic grain growers was completed in Fall 2001.

This program also encourages various extension and outreach activities. This year it provided for a visit from Professor Ron Cotterill to the Department of Rural Economy. Ron is an expert in antitrust cases in the American food business and presented a seminar on the importance of market structure on price transmission. ## A Major Academic Activity: Rural Economy Participation in Sustainable Forest Management - The Network of Centres of Excellence

The Sustainable Forest Management Network, one of Canada's 22 Networks of Centres of Excellence, is centred at the University of Alberta, but national in scope. This is a national research network focused on management of the boreal forest, involving university, industry, Aboriginal and government collaboration in research. The Faculty of Agriculture, Forestry and Home Economics plays a major role in this NCE. Several faculty members are principal investigators in the Network. Dr. Vic Adamowicz (Rural Economy) who has been Program Leader of the Network since late 1998 was on study leave from July 1 2001. Dr. Terry Veeman (Economics/Rural Economy) who is a co-theme leader of one of the three themes (Strategies and Institutions for Sustainable Forest Management) is Interim Leader of the Network from July 2001 through June 2002. In addition several Rural Economy faculty members have graduate students funded through the network.

The Sustainable Forest Management NCE is core funded by two federal granting councils: The Natural Sciences and Engineering Research Council (NSERC) and the Social Sciences and Humanities Research Council (SSHRC), in collaboration with Industry Canada. The Network is also supported by several industry partners, provincial governments, and First Nations partners. The Network's annual budget for research and networking is now over \$7 million. The Network has been extended with expanded federal funding for another four years in its second seven-year cycle.

The Network examines new approaches to forest management that can maintain the nation's forest based-economy while not compromising biodiversity and ecological goals. The Network has nine major research areas within three theme or legacy areas: Ecological Basis of Sustainability, Strategies and Institutions for SFM, and Minimum Impact Technologies. The theme areas interact to provide linkages between ecology, forest practices, processing and pollution control technology and social and economic development that are necessary to develop new approaches to forestry and new forest policies.

#### **International Projects**

Agroforestry Southern Africa Project is a five year project (M. Luckert, U of A Director), funded by the Canadian International Development Agency, that continued through 2001 and will conclude in 2002. It has provided for a continuation of many collaborative activities of Rural Economy and the University of Zimbabwe that were initiated through the earlier Value of Trees Project. In 2001 this project supported a series of short courses, contributed to the training of several graduate students, and aided the development of curriculum materials. Two Zimbabwean students who had been supported by this funding for MSc studies completed this and moved into the PhD program in 2001 (Sibgonile Moyo and Lorraine Dzuda). Another Zimbabwe student whose PhD program in Rural Economy is supported under this program is Chris Zindi.

Two further international projects of Rural Economy continued in 2001. One of these, funded by IDRC, is the *Community Land Management* (Zimbabwe) project which commenced in late 2000. This is providing for research in how communal property rights affect land management in Zimbabwe by

the University of Zimbabwe and the University of Alberta, (through Rural Economy). The project is providing funding for three PhD students, one of whom, Sibongile Moyo, is based at the University of Alberta.

Activities in 2001 for the three-year linkage agreement between Rural Economy and the Kenyabased International Centre for Research on Agroforestry, (ICRAF) which focuses on *Valuation of Environmental Services of Agroforestry Systems* included an Agroforestry Workshop in Chipata, Zambia in late May 2001. Six Rural Economy faculty members and four University of Alberta students participated in this informative research-oriented workshop.

#### **Rural Economy Facilities**

The Rural Economy Reading Room continues to be a valuable resource for the department and is well-used by students. The scope of the collection includes, in addition to the traditional areas of agricultural and resource economics, forest economics and rural sociology, related material on agroforestry, environmental economics, and resource sociology.

The Rural Economy Graduate Computing Laboratory was expanded in 2001 to a 12 work station research facility. This focuses on specialized software used in the disciplines of Agricultural and Resource Economics, Forest Economics and Rural Sociology. Competitive capital funding may enable further expansion of the scope and capacity of this facility in the subsequent year.
