Outcomes of the 2019 CARA Annual Conference

- The 2019 CARA Annual conference took place in Montreal from May 26-29, 2019.
- CIHR participated in a number of sessions/workshops, notably:
 - CIHR Strategic Plan: Similar session to the one for the upcoming UD Annual meeting.
 - CIHR Update: Was an opportunity to discuss topics of interest such as success rates, initiatives related to the College of Reviewers (e.g. Reviewer Pathway), changes to CIHR programs (e.g., sunset of Foundation Grant program), as well as policy and project updates (e.g., new CIHR Application Administration Guide, Knowledge User template).
 - Tri-Agency Update on Gateway: Gave an update on the grants management solution.
 - Implementation workshop on the Renewal of Tri-Agency Financial Administration Initiative
 - Tri-Agency Update
 - Canadian Common CV (CCV)
- All sessions were well attended and CIHR is pleased with the feedback it received from the research community through its various opportunities for engagement.

Launch of Dimensions: Equity, Diversity and Inclusion Canada

CRCC inaugural progress report

- The Canada Research Coordinating Committee (CRCC) released its first progress report on May 24.
- The committee was created to improve the coordination efforts of Canada's three granting agencies — SSHRC, NSERC, CIHR — as well as the Canada Foundation for Innovation (CFI). The first report provides an update on the important steps taken since the creation of CRCC, following the daily report, which was created at the end of 2017.
- One of the highlights is the launch of the [New Frontiers in Research Fund](#). The report also summarizes the progress made in five key priority areas of the CRCC:
 - Interdisciplinary, international, high-risk, high-reward and rapid response research;
 - Key emerging research areas;
 - Equity, diversity and inclusion in research;
 - Indigenous research; and
 - Early career researchers.
- The progress report provides an update of all five key priority areas but also includes interesting data on both the early career researchers and the equity, diversity and inclusion in research. This information is based on some of the data we started to collect from applicants by the self-identification questions and some data from the early career researchers have been based upon the agreed definition of the tri-agencies.

Questions from Members

Q: Is there a way that the FDN results can inform Project? That is, successful to both can choose either but if they choose FDN, that could theoretically 'free up' spots for more Project grants.

A: Depending on the outcome of the decisions for these competitions, the budget allocated to Project and Foundation shifts accordingly.

Q: My committee will get lucky to get three funded. If one gets Foundation funding, will we lose that spot?

A: Yes. There is no "next-in-line" funding process [if an individual turns down a Project Grant].

Q: Are institutional signatures required for the Collaborative Health Research Projects LOI?

A: No, they are not.

Q: Regarding the Institute Community Support Planning and Dissemination grants, would it be possible not to have the deadline occurring on or about the same day as Project (in Fall competitions or any future competitions)?

A: Recognizing that having competition deadlines 2-3 days apart is not ideal, we will look into what is feasible going forward.

2. CIHR Strategic Plan

- As of June 4th CIHR received just over 3200 visits to the site, with more than 500 registered users and 510 individual responses to the questions. We thank you for your support and continue to welcome your input.
- Analysis Plan: Approximately 10 qualitative researchers at CIHR will engage in structured qualitative analysis using NVivo software. The team is guided by Science Council and CIHR has created an External Expert Committee, comprised of qualitative research experts from across Canada, to review and validate the process.
- Reminder about two important upcoming events:
 - UD Annual meeting (June 21): We will talk about the six lines of enquiry within the survey and seek feedback collectively with Adrian Mota, who will walk us through and guide discussions.
 - Consensus Workshop (Sept 10/11): There are 125 slots for participants to actively get involved in helping CIHR shape the strategic plan. About 100 slots are filled, but a call was launched in the Access Newsletter for individual researchers to apply to attend by submitting their name to come to the event.

Questions from Members

Q: Is it useful to get institutional responses to the survey, in addition to individual ones?

A: Yes. We sent out the survey to over 150 organizations (major stakeholder groups), seeking their direct institutional responses. We are hoping to get hundreds of institutional responses.

Q: Who is filling the 100 spots of the workshop?

A: The first 100 or so are comprised of CIHR Scientific Directors, Governing Council members, IAB Chairs, Funding Partners, Citizens, Indigenous community members, government stakeholders, University representatives (e.g., U-15, HealthCareCan, University Delegates) and other stakeholders. The list will be published for transparency.

3. New Frontiers in Research Fund

- On May 13th, Kirsty Duncan (Minister of Science and Sport) announced the first 157 awards that were granted from the inaugural Exploration stream competition. - Anticipating the launch of another Exploration (2019) competition and a Transformation stream; discussions regarding their announcement are ongoing.
- The first investment of \$38 million will support early career researchers with 5 years or less of experience since their first academic appointment.
- Each recipient will receive up to \$250,000 over the next 2 years.

Questions from Members

Q: Could there be cooperation between the core Tri-Council programs and the NFRF, so that appropriate proposals could be flagged or recommended for the NFRF program?

A: We can look into it but the inter-program mechanism would not work in the sense that the NFRF is a program designed to fund what cannot be funded through existing Tri-Agencies programs/funding opportunities. There should not be a lot of crossover between programs. Proposals funded through the NFRF are meant to be different due to their high-risk and interdisciplinary nature.

Q: Are success rates published from NFRF competitions?

A: 1315 eligible application were submitted to the competition, with nearly 1700 NOIs and a total of 157 grants awarded.

Q: Hard to tell from the first competition but many seemed to be perfectly appropriate for Project.

A: Currently, only titles are available on the website. We hope to publish the summary of the proposals as well. It will take some time to zero in on the types of proposals that the program should be funding.

Q: Since both CIHR and SSHRC have funding opportunities for multi-disciplinary teams – whereas NSERC is limited to the Alliance program – does this mean that the NFRF will tend to fund in the STEM field?

A: No, absolutely not.

Side note: While NSERC Discovery Grants typically fund individual researchers, grantees can use the money on any project they want to pursue in the five years of funding.

Q: How much will Transformation scheme look like Foundation?

A: Transformation stream was not designed to look like any other program. It is possible to come back with this information at another meeting.

Q: We have noticed, in Quebec, a low number of funded French-language applications. Can you comment on this?

A: The number of French applications submitted was also very low. Statistics show that the success rate for French applications was a little below the success rate for English applications.

Q: When will reviewer feedback be provided to applicants?

A: We anticipate uploading and making information (i.e., ratings for three criteria and a general feedback document) available through the Convergence portal by the end of next week. Individual comments from reviewers are not available to applicants.

4. Tri-Agency Financial Administration Initiative

Phase 1: Tri-Agency Guide for Financial Administration

- The agencies will replace the [existing 2017 guide](#) by introducing a principles-based approach to the use of grant funds that is intended to reduce the administrative burden on the administering institutions and the Grant recipients.
- In order to validate the principles and approach, twelve administering institutions participated in a pilot, during which time feedback from users was sought on the new Guide.
- The final version of the new Guide will be available in Fall 2019, with the following transition plan in place:
 - Non-pilot institutions will continue to apply the 2017 Guide until April 2020, at which time the principles will be applied moving forward.
 - The 6-month transition period (September 2019 to April 2020) will provide the onboarding institutions time to conduct a Policy Gap Analysis, develop their internal Communications plan, and fully understand and digest the Guide.

Phase 2: Financial Monitoring Framework

- The Tri-Agency suspended its financial monitoring reviews, given the transition to a principles-based approach in determining the eligibility of expenditures from Tri-Agency grant funds.
- The Tri-Agency plans to pilot a new Financial Monitoring Framework in Fall 2019.
- Any “problem” transactions will be addressed through existing agency processes with the controls or procedures in place through the Remedial Action Plan.
- Expected outcomes:
 - Reduced burden for the institutions;
 - A sound approach to risk management
- Pilot institutions will be involved in piloting/testing a new approach to financial monitoring.
- CAUBO (Canadian Association of University Business Officers) will support the development and sharing of best practices.

Third area of focus: Modernization of post-award administration

- Involves regular, ongoing consultations with stakeholders to create an iterative process for continuous improvement.
- Areas of interest include:
 - Direct vs. indirect costs;
 - Reporting requirements;
 - Tri-Agency documentation;
 - Tri-Agency standardized form.
- Consultations began in 2018 and will continue throughout 2019, and possibly into 2020.

Supporting the change

- Researchers can continue with their existing grants.
- A grace period will be provided to allow administering institutions time to update their policies and procedures, as needed.

- Grant recipients and administering institutions will remain informed of progress and impacts of this initiative through web updates (http://www.science.gc.ca/eic/site/063.nsf/eng/h_97415.html), regional and national conferences, agency meetings with stakeholders and newsletter campaigns, etc.
- Supporting resources will be available to support stakeholders when the Guide goes live:
 - FAQ document
 - Best practices
 - Webinars

Questions from Members

Q: Many institutions have much stricter (and admin-heavier) policies than the new tri-agency guidelines. To what extent are institutions expected to reduce those burdens for grant awardees? Is there any obligations for institutions to do so?

A: The transition period allows administrative institution to take a look at their policies and determine whether changes could be made.

Q: Will there be audits conducted on a random sample of funded research grants, like NIH does?

A: The financial monitoring approach will be based on a risk assessment. We want to think of it as a partnership, not an audit, so we will be assessing the existing financial control/policies that are in place and stepping away from the transaction-based review.

Q: I know this states is a Tri-agency initiative, but will this change in administrative requirement happen across NSERC and SSHRC grants recipients as well?

A: Yes. One of the key objectives of this initiative is to harmonize across all three agencies.

Q: So less money required for admin-‘auditing’ and more money for research?

A: We hope so. The new approach is intended to increase efficiencies.
