The Western Centre for Economic Research (WCER)

Past Annual Reports have been based on the calendar year. The current Annual Report covers 15 months to allow a transition to future reporting based on the fiscal year.

Since its creation in 1985, the primary objective of the WCER is to disseminate timely and balanced research findings relevant to the Western Canadian economy. The research is intended to inform concerned citizens and to aid policy decisions made within government and industry throughout Western Canada and beyond.

Dr. Rolf Mirus assumed the positions of Director of the WCER and CN Executive Professor of Canada – U.S. Trade Relations when Mr. Helmut Mach stepped down on March 31, 2010. Dr. Mirus is a Professor Emeritus at the Alberta School of Business and previously held the position of Director from 2001 to 2005. Dr. Mirus replaced Mr. Mach who had 33 years of experience with the Government of Alberta, most recently with the Alberta Ministry of International and Intergovernmental Relations. In January 2011, Mr. Jason Brisbois became Director of the WCER. Mr. Brisbois came to the University after a career in public sector finance and economics which spanned 26 years, with positions in several provinces. Jason left the Federal Public Service in 2007 after 17 years as Chief Economist of Western Economic Diversification, Canada.

In 2010, the WCER undertook a final survey for the ATB Financial Business Sentiments Index[™] which measures business confidence in Alberta. Research projects included developing a cluster map for Aviation Alberta, exploring the application of advanced technology in Alberta enterprises and furthering work on diversification in Western Canada. The Western Canada Economic Expectations Survey, developed in partnership with the Canada West Foundation, was conducted twice in 2010 and then discontinued. Five CN Trade Forums were held focusing on international trade, Canada-India relations, the concept of a North American economic community, an Alberta trade agenda, and Canadian climate change policy. The WCER continued as the Secretariat for the Alberta Forestry Road Map Committee.

The WCER continues to increase its visibility through frequent interaction with the public media. The WCER was also a sponsor of the annual Economics Society of Northern Alberta's Outlook Conference.

Background on the Western Centre for Economic Research

Established in 1985, the WCER is a University of Alberta based research centre sponsored by the Alberta School of Business and has links with the Faculties of Arts (Department of Economics) and Agriculture, Life and Environmental Sciences (Rural Economy). The WCER is housed within the Alberta School of Business. The Centre's objective is to undertake research projects that contribute to evidence based government policy development, can be used for practical business planning purposes at the firm or industry level, and are capable of furthering academic research. The WCER tracked the performance of Western Canada's economy using indicators produced in-house under sponsorship from ATB Financial and indicators obtained from other sources.

The results of research findings and conference deliberations are distributed through a series of information bulletins and similar monographs where emphasis is continually placed on ensuring that the information is presented in a non-technical, accessible format. Information Bulletins are available from the WCER office (780 492 2235) or online at www.business.ualberta.ca/wcer. Frequent interaction with public media and an extensive web site further disseminate research findings.

The Centre's activities are often co-sponsored with other University of Alberta entities as well as with federal and provincial government departments and other research organizations at universities across the Americas.

Funding for the WCER is derived from three primary sources: fee-for-service contract work, financial support from the George Cormie Foundation and a pledged endowment by Canadian National Railway Company (CN) for transportation and Canada – U.S. trade research. The revenue stream from these endowments permits the WCER to consider some independent initiatives, and to involve academic staff and graduate students in its research activities.

Alberta Premier's Council for Economic Strategy

The Alberta Premier's Council for Economic Strategy has considered options which would assist in the transformation of the Alberta economy over the next 30 years, including initiatives which might facilitate greater economic diversification. The WCER contributed a submission on the constraints and barriers which need to be addressed, eliminated or reduced in order to fulfill the objective of increased international trade.

ATB Financial Business Sentiments IndexTM

The WCER conducted a final Alberta based, forward looking, quarterly survey of business confidence in March 2010. 400 businesses across Alberta and across industry sectors were surveyed to determine their outlook for future demand, employment needs, pricing and inventory levels. An index of business sentiments was developed based on survey results. To a considerable degree, the survey followed the EU format, an established and successful model. Indices of business activity and hiring intentions were also developed. The survey was undertaken for 17 consecutive quarters. The index was presented on the WCER web page and in Information Bulletins.

Alberta International and Intergovernmental Relations

The WCER continued its yearly review of Alberta merchandise exports to markets covered by free trade agreements such as the Canada-US Free Trade Agreement, the subsequent North American Free Trade Agreement and agreements with Israel, Chile, and Costa Rica. The results were published as Information Bulletin No. 147, *Alberta's International Merchandise Trade: Focus on Free Trade Agreement Partners*.

Aviation Alberta

In 2009, the WCER completed a cluster analysis of the Alberta Aviation sector of Aviation Alberta. To further increase competitiveness in Alberta's aviation and defence sector, it was deemed necessary to develop a current inventory of the business units

comprising the sector, as well as an accurate profile of products and services offered, sales volumes, corporate structures, firm size, supply chains, export patterns, and employment levels as well as other characteristics. To facilitate this inventory, the WCER conducted an on-line survey of 650 firms located in Alberta who are involved in the Aerospace and Defence Industry. The survey instrument was administered by the AICT department of the U of A. Completion and analysis of the survey continued into 2011. Work began in September of 2010 and continued into 2011.

Community Revitalization Levies

The WCER prepared a confidential tutorial of community revitalization. The Centre partnered with Dr. Brad Humphreys, Department of Economics.

Forestry Industry Sustainability and Competitiveness Committee Secretariat and Forestry Road Map

Alberta Sustainable Resource Development; Alberta Employment and Immigration; and Forestry Industry

The WCER continued in its role as Secretariat for Alberta's Forest Industry Sustainability Committee (FISC). In this role, the WCER overlooked the budget and arranged for various research projects for FISC to be undertaken. The WCER facilitated a workshop for invited industry leaders in the spring of 2010 to review policy issues and options and assisted FP Innovations with a workshop on wood products. The project was extended for another fiscal year, until March 31, 2012.

The Forestry Project was expanded to include the development of a Roadmap to 2020 for the Wood Products Sector in Alberta including bioenergy in Alberta.

Productivity Alberta

The WCER completed a project begun in 2009 under an arrangement with Productivity Alberta. The WCER reviewed the results from selected questions from Statistics Canada's 2007 and 2008 Update of the Survey of Advanced Technology to compare Alberta's results to those from Ontario and Canada. The results were delivered to Productivity Alberta in a power point presentation and observations were provided on areas were Alberta differed from the other jurisdictions, and on areas where all jurisdictions demonstrated relevant trends.

The project also included a review of recent literature from Statistics Canada, the Microeconomic Policy Analysis Branch of Industry Canada and other sources to ensure appropriate linkages between technology investment and enhanced productivity are being made. It also included discussions with the Statistics Canada officials who designed the survey and produced the CD to determine whether absolute figures could be obtained in addition to the percentage data presented in the CD, and to clarify future intentions with respect to the survey.

Western Canada Economic Expectations

The WCER continued its partnership with the Canada West Foundation to solicit views on the future economic performance of the Western provinces and the country and timely economic issues. In 2010, an electronic survey was sent twice to economists, and people who use economics in their work, in universities and colleges, industry associations, economic development agencies, the private sector and the public service across Western Canada. Results were released in February and December as Bulletin No. 137 *Western Economic Expectations Survey: February, 2010* and Bulletin No. 148 *Western Economic Expectations Survey: December, 2010*. Due to low response rates, the survey will not be continued in 2011.

Outreach

Expert Consultation

Staff provided expert consultation for various government councils and agencies including the Alberta Premier's Economic Strategy Council, the Alberta Finance and Enterprise Productivity Alberta Initiative, and the British Columbia Department of Higher Education Degree Quality Assessment Board for Bachelor of Commerce and MBA Programme. The WCER continued as a participant in the World Economic Survey from the Institute for Economic Research at the University of Munich.

Mr. Brisbois became director of the WCER in January 2011. In addition to arranging and directing the WCER's research agenda, he provides frequent commentaries on economic events on television, radio and print media in addition to appearing as a guest speaker at conferences and seminars. Mr. Brisbois serves on the Board of Directors of the Economics Society of Northern Alberta, the Van Horne Institute, and Port Alberta.

Research Professor, Dr. Edward Chambers

Dr. Chambers has been actively involved in the ongoing ATB Business Sentiments project and in the Diversification Project. He began work on an economic evaluation of Western Canada. Dr. Chambers is an Assessor with the British Columbia Department of Higher Education Degree Quality Assessment Board for B. Com and MBA Programme applications. He is a member of the Advisory Council of the North American Economic and Finance Association and he is Past President of the Oak Bay Probus Club.

Senior Economist, Dr. Joe Rosario

Dr. Rosario recently retired as Director, Planning Secretariat, Alberta Agriculture, Food and Rural Development. He served as the most senior policy advisor, economist and trade policy advisor for Alberta Agriculture during a career which spanned 35 years. Dr. Rosario is focusing on agriculture initiatives. His broad economic background is available to provide advice on general economic and competitiveness issues for the WCER.

Project Coordinator, S. Stephen Janzen

Mr. Janzen continued to be involved with the Centre's forestry file and its work as a Secretariat for Alberta Sustainable Resource Development. He helped facilitate a wood products workshop with FP Innovations in April of 2010 and a workshop on policy options for Alberta's forestry leaders at the Alberta School of Business shortly thereafter. There was also a continuation of work evaluating the Alberta and Western Canadian economy with Dr. Chambers, the Canada West Foundation and others.

WCER Coordinator, R. Jean Frost

Mrs. Frost undertook the administrative duties of the WCER. She provided editorial skills and helped organize various forums.

Research Assistant, Nicolas Emter

Mr. Emter (BA Honours, 2009) worked through the spring and summer as an economist. Nicholas assisted on projects analysing the Alberta recession and technology and productivity. Nicholas co-authored Information Bulletins 138 and 147. Nicholas has resumed his studies in the Faculty of Law, University of Alberta but continues to undertake research for the WCER.

Public Relations

The WCER is frequently asked by the media and by others for assessments of economic conditions in Alberta and other Western provinces. Priority is continually placed on prompt and credible response to these inquires. The WCER provided comment on economic news and contributed numerous opinion editorials to the Edmonton Journal and staff were interviewed for television and radio programmes throughout the year. This has yielded increased visibility of the Centre and the Alberta School of Business.
