Rural Economy's Annual Report provides a wealth of information of the many activities, achievements and events during the preceding year. Our Annual Report is our most comprehensive means for us to communicate with our valued friends, within and outside the University of Alberta, about some of our achievements. Rural Economy had an extremely productive year in 2006. Our award winning staff and students were recognized for teaching abilities, both internally and externally, for career wide contributions to professional organizations (International Association of Agricultural Economists) and for research excellence in terms of quality refereed output. Graduate students were very successful in obtaining these research awards and in obtaining scholarships. Our undergraduate students placed first in a North American Food Distribution Research Society Case Study Competition. The above highlights only some of our activities and I encourage you to read the entire report to get the complete picture.

Our faculty continue to be very successful in competitive research grant opportunities. Researchers were successful in obtaining funding from a variety of national and provincial sources to examine everything from consumer response to fat taxes to socio-economic impacts of BSE on Alberta and Canada. These projects, as well as others, reflect our response to the pressing needs for research in the agriculture, food, forest and environment from both sociology and economics perspectives. Our multi-disciplinarity continues to be a strength of our Department.

A team of undergraduate students from Rural Economy went to Quebec City, October 14-17, 2006 to participate in the Seventh Annual Food Distribution Research Society Undergraduate Case Study Competition. The live case was sponsored by Sobey's Canada and was based on a timely strategy issue of a Quebec hothouse tomato producer called Les Serres du St-Laurent Inc. The company is currently the largest branded hothouse tomato producer in Quebec and has achieved 70% brand notoriety in the province for their Savoura brand tomato. The Savoura brand has been threatened as of late by new nationally branded tomato competition in the province and Les Serres du St-Laurent Inc. was seeking new strategies to mitigate the new tomato competition issue. The team of James Benkie, Cheryl Davie, Brian Markert, Ashley Pearson and Amee Persson continued the U of A's sequence of strong performances at this annual event by placing first with their marketing strategy titled: "Savoura: Creating Market Pull."

A number of students participated in the Undergraduate Competitions at the American Agricultural Economics Association Annual Meeting held in Long Beach, California from July 23-26, 2006. Dana Harper received second place for her paper titled: An analysis of the decline in hunting participation in Alberta. Curtis Boyd received third place for his paper title: 'Eggsactly' What attributes drive consumer egg purchases? Kendra Isaac received fifth place for her paper title: Drive-thru emission: An examination of vehicle drive-thru idling in the city of Edmonton. The graduate student team of Cheryl Davie, Vanessa Goodman and Wanjing Hu received second place for their case study presentation: Sun-Maid: Cooperative value.

Several undergraduate students participated in the 2006 Business Planning Award sponsored by Farm Credit Canada. A panel of four judges - Scott Ingledew (Serecon Consulting), Jolene Ali (private industry), Tomas Nilsson (U of A) and Bodo Steiner (U of A) - had the difficult task of choosing the

winning teams.

The first prize went to Brian Markert, Joel Conrad and Jesse Cole for a business plan on biofuel, made from rained on timothy hay. Solid financials and an innovative approach to promoting their hay pellets to small and medium sized enterprises made their business plan a winning formula. The second prize went to Cara Taylor, Chuck Schwanbeck, James Benkie, John Chibuk and Kelly Hays for their innovative business plan for a biodiesel production company in Alberta. Using low-cost animal fat, the students made a strong case for a biodiesel provider to commercial fleets and transit services in Canada and the U.S. The third prize was awarded to Melissa Reinhardt and Gerda Hijlkema for a business plan that looked into developing a value added meat processing plant in Alberta. The students aimed to establish a distinguishing brand name for beef jerky, fresh and cooked sausage, and hotdogs from Alberta.

Brett Cortus posthumously received one of two honorable mentions in the Master Thesis Award category from the American Agricultural Economics Association for this thesis titled: "The Economics of Wetland Drainage: A Case Study in Canada's Prairie Pothole Region." (Supervisor: S. Jeffrey).

Gloria Gao received the 2006 Food Distribution Research Society William Applebaum Memorial Scholarship for an Outstanding MSc Thesis for her thesis titled: "Consumer Behaviour: Who Seeks Information about Genetically Modified Foods?" (Supervisor: M. Veeman and W. Adamowicz).

Getu Hailu received the 2006 Food Distribution Research Society William Applebaum Memorial Scholarship for an Outstanding PhD Dissertation for his thesis titled: "Principal-Agent Problems and Capital Constraints in Canadian Agribusiness Supply and Marketing Co-operatives." Overview of the Cooperative Program in Agricultural Marketing and Business

The Cooperative Program in Agricultural Marketing and Business was created by industry funding in the late 1980's. The broad purposes of the program are to conduct research, extension and teaching in the areas of agricultural marketing and business. The focus is on issues related to group activities whether these be for cooperatives or other organizations.

The Co-operative Program did not have an Annual Symposium this year but did continue to maintain a focus on research output. The Program had three Masters students complete, Freda Glover, John Paul Emunu and Oybola Jegede. These students all completed research projects of interest to the original funders of the program; a comparison of economic efficiency across agricultural marketing co-operative sectors, public understanding of co-operatives in Alberta, and the market for highly differentiated egg products within Canada. Continuing PhD and Masters students are undertaking research on changing ownership in the grain handling sector, economic game playing among co-operatives, non-co-operatives and government in the processed food industry, potential effects of trans-fats regulation on the oilseed and dairy sectors.

Students working in the Cooperative Program were well represented in various national and international professional meetings throughout the year. Students presented at the Canadian Association for Studies in Co-operation annual meeting, the Canadian Agricultural Economics Society annual meeting, and the American Agricultural Economics Association meetings and produced publications in various journals.

Rural Economy Facilities

The Rural Economy Reading Room continues to be a valuable resource for the department and is well-used by students. The scope of the collection includes, in addition to the traditional areas of agricultural and resource economics, forest economics and rural sociology, related material on agroforestry, environmental economics, and resource sociology.

The Rural Economy Graduate Computing Laboratory was expanded in 2003 to a 13 work station research facility. There are three types of workstations in the computing lab, designed for different types of work.

The most sophisticated machines in the lab are designed for computationally intensive operations such as number crunching with large data sets. These machines are dual processor, dual monitor machines with lots of memory and large hard disk drives. This allows students to work with very large data sets in an efficient manner without taxing network bandwidth. There are four of these in the lab. These machines also have the linux operating system installed for use by students who may need development tools and other packages that windows does not provide. These machines have the ArcGIS software suite installed for simple access to GIS functionality. Additional and more comprehensive access to GIS is available through the SIS Lab.

The next class of machines in the lab are high end workstations that are suitable for graphics manipulation and medium duty number crunching. They are single processor machines with a single monitor and large hard drives. There are five of these machines. The last types of machine available are a group of four lower end workstations that are used for general purpose email and word processing. These are the next machines scheduled for replacement.

In addition to the Graduate Computing Lab, each of the grad student offices is equipped with a workstation that contains the same software as the lab machines. These are medium performance workstations that are suitable for word processing, simple data analysis, internet access, etc.

The department also has the ability to conduct online surveys, via a dedicated, web based survey system which makes heavy use of open source software to provide a simple, robust mechanism for design of surveys and simple, easy access to the recorded data. There are also several portable versions of this survey setup, allowing the conduct of mobile surveys using a variety of input devices such as laptops, tablet PC's and embedded touch screen devices.

The departmental file server has recently been replaced with a state of the art machine to provide increased performance and storage capacity.
