INTRODUCTION

This study is based on data of exports from Alberta in 2000. It is intended to assist in the identification of current and potential foreign markets deserving tariff reduction/elimination efforts and it is a guide to which products should be prioritised in future multilateral trade negotiations.

The analysis is focused on those countries with which Canada does not have a Free Trade Agreement. For this purpose, Chile, Costa Rica, Israel, Mexico and the United States are not included.

FORMAT

The products are classified according to the Harmonized Tariff Coding System (HS Codes). HS Chapters or group of like Chapters divides the study, and the product description is detailed at the 6-digit level in the HS coding system.

The threshold used for this study is CAD 500,000 in total shipment value to non-FTA countries in 2000. Differing from the previous study by Hou (1999), products for which the **sum** of Alberta exports to non-FTA countries met the threshold were included, even if no particular country individually met the threshold. As a result, the number of products included is larger than in the previous version.

In each Chapter, three items are shown:

1. *Summary Tables of Bound Tariffs and Export Values for 2000*: Tables provide detailed information about selected products in each HS Chapter or group of similar Chapters. It includes the bound tariffs they face in the various countries, as well as the total value of exports for selected countries.
2. *Tabulation of Recent Export Values*: Tables summarize the total annual export value of selected products for the 1995 to 2000 period. The total values shown represent shipments to all non-FTA countries, and are intended to demonstrate variations/fluctuations in the level of exports, as well as to identify trends in the non-FTA markets.
3. *Comparison of Alberta's Exports in 2000 to non-FTA and FTA Nations*: Charts provide a comparison of total volume of exports between non-FTA and FTA countries for selected products.

THE SUMMARY TABLES OF BOUND TARIFFS AND EXPORT VALUES FOR 2000

The maximum tariff that can be imposed as a result of concessions made during the Uruguay Round is referred as the "Bound Rate". The availability of data limited this study as the Bound Rate of WTO member countries as reported in the Tariff Schedule from the Uruguay Round of negotiations in 1996.

However, many non-WTO members received significant levels of exports from Alberta in 2000. These countries were included in the study and are denoted in italics within the tables.

Members of Asia-Pacific Economic Cooperation (APEC) have more updated information regarding tariffs. For the most part, these countries provide their APEC

Most-Favoured-Nation (MFN) tariff levels in a publicly accessible database. As Canada is part of APEC, the MFN tariff is shown for these countries.

For countries that are members of both WTO and APEC, the tariff rate considered for the purpose of this study is the one provided at the APEC website. The reason for discarding the information of the Uruguay Round for these countries is that the MFN rates for APEC are more up-to-date than the Bound Rates agreed at the Uruguay Round.

Therefore, the tariff rates presented for the following countries are the ones published at the APEC website: China, Taiwan, Hong Kong, Australia, Korea, Japan, Philippines, Malaysia, New Zealand, Indonesia, Peru and Singapore.

Even though Russia, Thailand and Vietnam are members of APEC, their tariff information is not available. In these cases, as well for other countries when tariff information is unavailable, the summary tables show "n.a." ("not available").

Members of the European Community are simply grouped as the "EU 15". Its members are Belgium, Germany, France, Italy, Luxembourg, Netherlands, Denmark, Ireland, United Kingdom, Spain, Portugal, Greece, Austria, Finland and Sweden.

NOTES

As the threshold of CAD 500,000 is used to filter the level of exports, this study does not capture all potentially valuable products exported and facing restrictive barriers abroad.

Further, this study focuses on WTO "bound" rates. It is possible, however, that a country is applying duty rates that vary from the bound rates listed in its WTO Schedule. The "bound" duty represents the maximum tariff a country may legally charge on imports, but is not necessarily the actual duty currently imposed.

Concordance problems may arise when the tariffs are applied at 8 or 10-digit level, since countries classify goods at their discretion at these levels. This study reconciles these variations by providing the range within which these tariffs fall at the 6-digit level.

Exports from Alberta accounted for more than \$55 billion in 2000. The United States is the primary destination of Alberta products (88.3%), and the FTA nations all together account for more than 89.2% of total exports. Non-FTA nations imported a total of \$5.9 billion in 2000 or 10.8% of total exports. In general terms the top-10 non-FTA destinations for Alberta products are Japan, the European Communities (EU 15), China, South Korea, Taiwan, Iran, Australia, Brazil, Indonesia and Venezuela. The top 4 together represent 6.6% of total exports, or 62% of exports to non-FTA countries.



Alberta beef continue to be exported to Asia, Japan and South Korea being the most important non-FTA countries where frozen cuts are concerned. The tariffs faced at these destinations are high, typically ranging 40% to 50%. However, the volume of fresh beef exported to the US by far exceeds the volumes shipped to other destinations.

Europe is the main destination for horsemeat, while Japan continues to be the main destination for pork exports. The total volume of exports of HS 020329 (frozen boneless pork cuts) to non-FTA countries doubled in 2000. The bound tariffs imposed by Japan on pork are not as restrictive as those imposed on beef.


Asia is also the main non-FTA destination of several types of edible offal. The tariff restrictions for these products also deserve consideration for reduction efforts.

Frozen chicken cuts exports continue to rise. Total exports to non-FTA nations were above \$2.3 million in 2000, Cuba being the most important destination where the bound tariff imposed is high (40%).



Alberta honey exports recovered in 2000, reaching \$6 million, of which \$2.3 million were shipped to non-FTA countries. The EU 15 is the primary destination and the bound rate faced is 17.3%.




The most important destinations for Alberta peas exports in 2000 were South East Asia and Europe. The bound rates imposed by Bangladesh, India and Pakistan are 200%, 100% and 100% respectively, and deserve consideration for tariff reduction efforts. Bangladesh alone imported more than \$28 million in peas in 2000. The EU 15 have a zero tariff for this product.

Colombia imposes a tariff of 178% on beans and is a large importer of the Albertan product.


Tariffs on cereals vary across nations, as political and social economic issues such as subsidies and farm support are discussed. It seems that an agreement for reduction in import duties of cereals is still far from being reached.


Another relevant factor is that wheat and malting barley in Western Canada have their export prices controlled by the Canadian Wheat Board.



Malt is the most important product in this chapter, reaching \$95 million in exports in 2000 (34% increase from 1999), of which \$66 million went to non-FTA countries. Japan, Brazil and South Korea were the most important destinations. The bound tariffs faced by these countries are medium to high and so deserving of consideration for reduction.





















Low-density polyethylene is an important type of plastic exported by Alberta. Even though the exports to FTA nations represent more than half the value shipped abroad, exports to non-FTA countries accounted for \$197 million in 2000. China and the EU 15, with bound rates of 18% and 6.5%, respectively, are the dominant markets for this product. Polyethylene and a variety of other plastic products are exported to many countries. 
























Less than 8% of Chapter HS 85 exports were shipped to non-FTA nations in 2000. As in chapter 84, these exports are composed of a large variety of products and typically exported in small volumes to different countries. The EU 15, Taiwan, Hong Kong and Australia were the major non-FTA destinations of electrical machinery and parts in 2000. The most important products in this chapter are in the telecommunications categories. Increasing the number of signatory countries of the IT Agreement of Singapore would be beneficial to Alberta, as some large volumes are exported to nations not included in the agreement.









Almost 41% of Chapter HS 90 exports were shipped to non-FTA nations in 2000. As in chapters 84 and 85, these exports are composed of a large variety or products, typically exported in small volumes, to different countries. Artificial body parts and different precision instruments and apparatus are the most important products. The EU 15, Norway and Japan were the major non-FTA destinations of HS 90 in 2000. Tariffs, with a few exceptions, are not high in this chapter.


