The member states of the Organization of American States (OAS) will convene in Quebec City from April 20-22, 2001 for the *Summit of the Americas*. One of the priorities for this meeting is to begin negotiating the *Free Trade Area of the Americas (FTAA)* which is described as "the centre-piece of efforts to advance prosperity in the Hemisphere through economic growth and development".¹

Alberta seeks to promote trade liberalization within the hemisphere, particularly with its largest trading partners and where tariffs are most restrictive. In an effort to assist in the identification of these priorities, this report has been compiled. It summarizes Alberta's export relationships with the members of the Organization of American States¹ less the United States and Mexico. Cuba, although not an OAS member, is included because it belongs to the World Trade Organization and, relative to the hemisphere, is a strong importer of Alberta goods.

FORMAT & METHODOLOGY

A) TIME PERIOD

The export trade data used for this report covers the first nine months (September to January) of 2000. This period was chosen because only third quarter data was available for 2000 at the time this report was written.

B) CATEGORIZATION OF PRODUCTS

The Harmonized Tariff Coding System ("HS Code"), used to categorize the goods, are grouped first into two digit chapters and then into more specific categories at the six digit level. The data was derived from the "World Trade Atlas System".

C) SIGNIFICANT EXPORT ITEMS

For the purposes of this study only significant export items are considered. This means that a country is importing at least *\$375,000* (Canadian Dollars) of an Alberta product at the six-digit level in the nine-month period of January – September 2000.² The report provides tabular details on each HS Chapter relevant to this trade group and the bound tariff rates that Alberta exports face in each country. The value of Alberta's exports to each of these countries for 2000 (January to September) is also provided. The data was derived from the "World Trade Atlas System". Please note that all monetary figures are in Canadian Dollars.

² At the time of this report's writing, only nine months of data (January-September) were available for 2000, therefore the annual significant export level hurdle rate of %\$500,00 was pro-rated to \$375,000.

D) BOUND TARIFF RATES

The report presents significant export products for each 6-digit code and by country. Accompanying this information, as available, is the figure for the bound tariff rate. The "bound rate" refers to the maximum tariff that can be imposed as a result of the concessions made during the Uruguay Round. The bound rates come from the World Trade Organization in a CD called "The Results of the Uruguay Round". Chile is an exception as some goods fall under specific tariff reduction categories of the Canada-Chile Free Trade Agreement. (See Section 3).

E) COUNTRIES INCLUDED IN THE STUDY

This study considered Alberta exports to thirty-two countries. The countries are the members of the Organization of the American States less the United States and Mexico. Cuba, not a member of the OAS, was included in this study. All countries examined are members of the World Trade Organization except for Bahamas and Grenada.

REGIONAL & BILATERAL TRADE AGREEMENTS RELEVANT TO THIS STUDY

A) CHILE-CANADA FREE TRADE AGREEMENT (CCFTA)

Based on the CCFTA, certain categories of goods are scheduled for accelerated tariff reduction and removal. Based on the schedule available through the Department of Foreign Affairs and International Trade, over 100 products at the 6-digit level have been allocated a specific category for tariff reduction. There are 16 different categories in Chile's schedule for tariff reduction and elimination (A+, A*, AB, E, B-, B, B+, F, BC, C-, C, C*, C-15, C-16, C-18, Y). Only four were relevant to Chile's significant imports and are described below. However, not all of the products imported at a significant level by Chile appeared in this schedule. In such cases, the bound rates from the Uruguay Round were used.

B) CANADA-CENTRAL AMERICA FOUR (EL SALVADOR, GUATEMALA, HONDURAS, NICARAGUA) FREE TRADE AGREEMENT (IN NEGOTIATION)

At the Canada-Central America Summit in Guatemala on September 28, 2000, Canada agreed to a request by the leaders of the Central American countries of El Salvador, Guatemala, Honduras and Nicaragua to begin free trade negotiations. On January 9, 2001, International Trade Minister Pierre Pettigrew announced that the Government would embark on a broad and comprehensive consultation process to define the scope of such an initiative with the Canadian public, the provinces and territories, businesses and NGOs.

Based on the parameters of this study, Guatemala was Alberta's sixth largest export market, with seven products at the significant export level. El Salvador, Honduras, and Nicaragua had no imports at the significant level.

C) CANADA-COSTA RICA FREE TRADE AGREEMENT (IN NEGOTIATION)

Free trade negotiations between Canada and Costa Rica were launched on June 30, 2000 and, to date, there have been several rounds of negotiations. A wide variety of topics are being discussed during these negotiations and are grouped as:

- 1. Market Access
- 2. Government Procurement and Competition Policy
- 1. Dispute Settlement and Institutional Provisions

Recently, two other groups have been formed to hold separate discussions on labour and environmental issues, with a view to concluding side agreements at the same time as the free trade agreement.

According to the Department of Foreign Affairs and International Trade, discussions to date have been productive, with the text of the Canada-Chile Free Trade Agreement (CCFTA) being used as the basis for talks. Canada is optimistic that an agreement can be concluded as early as the spring of 2001.

D) CARIBBEAN COMMUNITY & COMMON MARKET (CARICOM)

The Caricom treaty (established 1973) covers the English speaking Caribbean territories of Antigua and Barbados, Bahamas, Barbados, Belize, Grenada, Haiti, Montserrat (not an OAS member), St. Lucia, Trinidad & Tobago, St. Vincent & the Grenadines, Suriname, St. Kitts & Nevis, Jamaica, Guyana, and Dominica. Caricom permits duty free imports of locally produced goods to member countries. Goods enter member countries duty-free, provided the value added in the country of origin is at least 40% for goods produced in the Less Developed Countries (Antigua, Belize, Dominica, Grenada, Montserrat, St. Kitts & Nevis, St. Lucia, and St. Vincent) and 50% for goods produced in the More Developed Countries (Jamaica, Guyana, Barbados, and Trinidad and Tobago).

Caricom is working towards the establishment of a Common External Tariff (CET) although different countries are at different stages of CET implementation. Earlier attempts to meet deadlines for establishing a common external tariff have not been successful.

E) CARIBBEAN – CANADA TRADE AGREEMENT (CARIBCAN)

Caribcan is a Canadian economic and trade development assistance program aimed at the Commonwealth Caribbean. Caribcan provides duty-free access to the Canadian market for many of the current exports to Canada. Duty-free access also covers a wide range of goods nor currently exported from or manufactured in the Caribbean. Duty-free access applies to all goods unless it has been determined that their access would adversely affect certain sensitive economic sectors in Canada. These products include clothing, textiles, footwear, luggage, handbags, and leather garments, lubricating oils and methanol products.

F) MERCOSUR

MERCOSUR is a free trade pact among Brazil, Argentina, Paraguay, and Uruguay. There has been criticism that MERCOSUR's external trade barriers are too high.

CONCLUSION

This report confirms that Alberta enjoys vibrant export relationships with many countries of the Western Hemisphere. The intention to exclude the United States and Mexico from the analysis serves to underscore the importance of such markets as Chile, Brazil, Argentina, Venezuela, and Cuba. While there exists some homogeneity in the largest export categories across many of these markets, there are emerging categories of value-added exports upon which Alberta can capitalize.

It is hoped that this report helps Alberta trade officials prepare for the upcoming Summit of the Americas. The country profiles for the top ten export markets and the associated tariff rates should help Albertans better realize their export potential.
