Rural Economy in 2008: Chair's Message:

The end of this year has seen a number of changes in the Department. First, Dr E. Goddard's term as Chair has ended and she has started a year of leave following her 6 years in the position. Under her leadership, this Department has grown to be the largest and most productive of its kind in Canada. E. started a number of initiatives and traditions which will continue into the future. Among these are a significant increase in graduate student numbers, increases in the number of Faculty positions, and Departmental support for increased graduate and undergraduate student involvement at national and international conferences. These actions have placed the Department of Rural Economy on the centre stage of Agricultural, Environmental and Resource Economics and Sociology in Canada. We owe E. a tremendous debt of thanks for her efforts in leading us.

We welcomed Dr. Philippe Marcoul to the Department in 2008. Philippe has research interests in industrial organization and cooperatives and comes to us from Iowa State University. Other current faculty had highly successful years. S. Cash won the Provost's Award for Early Achievement of Excellence in undergraduate Teaching. M. Luckert was a Killam Annual Professor, and Debra Davidson won three awards (!) – the NACTA Teaching Award of Merit, the Faculty Teaching Award, and the Faculty Research and Innovation Award. These Faculty achievements, along with the numerous awards of graduate and undergraduate students won this year, underpin the highly productive nature of our Department.

This year our graduate student organization (REGSA) organized and ran a number of highly successful events. John Pattison, Jesse Cole and Wayne Crosby led a "Farm Tour" through the Kingman area which culminated in a community barbeque in the local hall. This was a tremendous event in which students, staff and community members shared questions and information. This event served as an important step towards a productive and communicative partnership between the Department and the Kingman producers. Thank you to all who attended and to the kind people of Kingman who hosted us.

I have been acting Chair since July 1st 2008. My plans in leading the Department through the next year involved a reorganization of the Department front office to meet the increases in student and Faculty numbers, and a rationalization of some of the more temporary measures of the staff complement. These initiatives will unfold during 2009.

<u>Overview of the Cooperative Program in Agricultural Marketing</u> <u>and Busines</u>

The Cooperative Program in Agricultural Marketing and Business was created by industry funding in the late 1980's. The broad purposes of the program are to conduct research, extension and teaching in the areas of agricultural marketing and business. The focus is on issues related to group activities whether these are for cooperatives or other organizations.

The Co-operative Program Annual Meeting in 2008 focused on summarizing all activity since the inception of the program with the current and past members of the Co-operative Council. The meeting was held in December 2008 and featured Philippe Marcoul as a guest speaker on 'Managerial Incentives Pay in Co-operatives: Is it different? Important Challenges for the Future' (co-author Brent Hueth). Significant discussion was held on the future of the co-operative program among council members present.

The Program had one Masters student complete, Lola Ajayi-Lawrence, thesis entitled Characterization and Assessment of Human and Environmental Health Risks Associated with Urban and Peri-Urban Livestock Keeping in Kaduna Metropolis, Nigeria. M.Sc. Lola has gone on to work for IDRC in Ottawa subsequent to her graduation from the University of Alberta. Continuing PhD and Masters students are undertaking research on

- willingness to pay for traceability and animal testing in the livestock and farmed cervid sectors
- strategic firm interactions in pricing, advertising and product quality in the Canadian meat industry
- political economy of BSE animal testing and traceability in Canada, Japan and the U.S.
- certification and consumer interest in credence production attributes in Canadian agriculture
- food away from home purchases and their drivers and implications for health.

Students working in the Cooperative Program were well represented in various national and international professional meetings throughout the year. A group of 7 Department of Rural Economy undergraduate students: Jason Forster, Brenda Campbell, Justin Weiss, Dustin Dinwoodie, Connor Laforge, Tyson Bieleny and Daniel Leon, participated in the 2008 National Ag-Marketing Association Student Marketing Competition, under the supervision of Ellen Goddard. The U of A group presented a comprehensive marketing plan for a new higher oil yielding canola variety. The students received support from Monsanto, the Western Producer and the Department of Rural Economy to attend the competition.

Rural Economy Facilities

The Rural Economy Reading Room continues to be a valuable resource for the department and is well used by students. The scope of the collection includes, in addition to the traditional areas of agricultural and resource economics, forest economics and rural sociology, related material on agroforestry, environmental economics, and resource sociology.

The Rural Economy Graduate Computing Laboratory was expanded in 2003 to a 13 work station research facility. There are three types of workstations in the computing lab, designed for different types of work.

The most sophisticated machines in the lab are designed for computationally intensive operations such as number crunching with large data sets. These machines are dual processor, dual monitor machines with lots of memory and large hard disk drives. This allows students to work with very large data sets in an efficient manner without taxing network bandwidth. There are four of these in the lab. These machines also have the linux operating system installed for use by students who may need development tools and other packages that windows does not provide. These machines have the ArcGIS software suite installed for simple access to GIS functionality. Additional and more comprehensive access to GIS is available through the SIS Lab.

The next class of machines in the lab are high-end workstations that are suitable for graphics manipulation and medium duty number crunching. They are single processor machines with a single monitor and large hard drives. There are five of these machines. The last types of machine available are a group of four lower end workstations that are used for general purpose email and word processing. These are the next set of machines scheduled for replacement.

In addition to the Graduate Computing Lab, each of the grad student offices is equipped with a workstation that contains the same software as the lab machines. These are medium performance workstations that are suitable for word processing, simple data analysis, internet access, etc.

The department also has the ability to conduct online surveys, via a dedicated, web based survey system which makes heavy use of open source software to provide a simple, robust mechanism for design of surveys and simple, easy access to the recorded data. There are also several portable versions of this survey setup, allowing the conduct of mobile surveys using a variety of input devices such as laptops, tablet PC's and embedded touch screen devices.

The departmental file server has recently been replaced with a state-of-the-art machine to provide increased performance and storage capacity.
