A related focus of Rural Economy's research mission is the pursuit of public involvement to ensure relevance and effectiveness in the discovery, application and dissemination of knowledge in our areas of focus.

Rural Economy's Annual Report provides a wealth of information of the many activities, achievements and events during the preceding year. Our report includes a listing of our staff members and their major areas of teaching, research and other responsibilities. An account of the research output of the staff of the Department is given by the listing of their publications and research grants. Our Annual Report is our most comprehensive means for us to communicate with our valued friends, within and outside the University of Alberta, about some of our achievements. Other information on Departmental activities, including graduate programs, courses and course descriptions, is available on our webpage (www.re.ualberta.ca) and through our regular newsletters. Full contact details are on our recently upgraded web site.

Rural Economy had many significant achievements in 2005.

We had the pleasure of hiring new staff members, Chokri Dridi, who has interests in resource economics with a particular focus on water and Tomas Nilsson, who has interests in agricultural marketing issues and market structure. Various staff and students won awards through a variety of venues. Vic Adamowicz received the University of Alberta's highest research honour in the J. Gordon Kaplan Award, only the second person ever to win this award from our Faculty. Peter Boxall was awarded a Killam Annual Professor award in another University wide competition. These awards both reflect incredibly high levels of productivity and my colleagues are to be widely commended. One of our Phd graduates, Wuyang Hu, who has taken employment in the Department of Resource Economics at the University of Nevada, received major recognition for his PhD thesis, winning an Honourable Mention from the Canadian Agricultural Economics Society and the William Applebaum Award from the Food Distribution Society. The above highlights only some of our activities and I encourage you to read the entire report to get the complete picture.

Our faculty continue to be very successful in competitive research grant opportunities. Researchers were also successful in obtaining funding from a variety of national and provincial sources to examine

everything from consumer concerns about health risks from local water, carbon credit trading, CLA enriched milk products to community provision of antiretroviral treatments for AIDS patients in rural Uganda. These projects, as well as others, reflect our response to the pressing needs for research in the agriculture, food, forest and environment from both sociology and economics perspectives.

Continuing enhancements to the collections held within the Eric Berg Reading Room and to the Research Computing Lab provide enrichments to the teaching and research programs of staff and students within our Department. Both of these facilities have benefited from the success of staff in obtaining competitive grants and from the generous donations of many friends to the Department.

We were saddened by the passing of Brett Cortus, an outstanding recent MSc graduate in Agricultural and Resource Economics. Brett had a lifelong interest in issues related to agriculture and environmental quality and undertook his research on a farm drainage project funded by Ducks Unlimited. He was also one of the first round winners of a SSHRC Masters Scholarship. Friends and family have created the Brett G. Cortus Memorial Scholarship in his name and contributions can still be made c/o the Department of Rural Economy.

I wish to take the opportunity to thank the many individuals who have contributed to the achievements of the Department this year. These include staff, both academic and support, colleagues across North America who contribute to collaborative research programs and to providing input on staff promotion, evaluation and nomination for awards, and our many contributors from government and industry within Alberta who provide input on Advisory committees (e.g. Cooperative Chair in Agricultural Marketing and Business) and research and teaching collaborations.

Their in-depth business plan evaluated a proposal to take a small lambing operation to a larger combined breeding and finishing operation. A number of interesting product innovations were proposed, together with innovative ideas for generating funds.

Miranda Baniulis and Greg Nichiporik were awarded a prize from the Department of Rural Economy for their business plan that proposed the formation of an innovative beef producing cooperative. Their plan pointed to ways of avoiding the typical life cycle conflicts that many other cooperatives are facing.

Overview of the Cooperative Program in Agricultural Marketing and Business

The Cooperative Program in Agricultural Marketing and Business was created by industry funding in the late 1980's. The broad purposes of the program are to conduct research, extension and teaching in the areas of agricultural marketing and business. The focus is on issues related to group activities whether these be for cooperatives or other organizations.

The program funding is largely used to fund graduate student research. Currently there are three Masters students and two PhD students funded through the program. Their research topics vary from: Efficiency in Agricultural Marketing Co-operatives to Strategic Marketing Games Played by Processors

and Retailers to Factors Affecting the Demand for Eggs in Canada.

Students working in the cooperative program were well represented in various national and international professional meetings throughout the year.

The program also encourages various extension activities. This year the highlight of the program was the Annual Symposium. Symposium 2005 "What Do Consumers Really Want?" was held on June 1, 2005 at the University of Alberta. Consumer demand for food continues to be one of the most complex factors affecting agribusiness. New research tools are allowing us to determine what consumers will purchase in the future and why certain foods are less than popular. Symposium 2005 provided us with an opportunity to examine consumer demand for a variety of foods and product attributes. Invited speakers from the U.S. included Randy Westgren (University of Illinois) who spoke on U.S. and Canadian consumer's attitudes towards functional foods and Leigh Maynard (University of Kentucky) who spoke on how important it is to look at consumer demand at the brand rather than commodity level. Rural Economy professors spoke on a variety of topics: Ellen Goddard spoke on the impact of agricultural policies on food choices and on consumer preferences for eggs by production attribute (health, organic, animal friendly), Sean Cash spoke on the merits of 'fat' taxes versus thin subsidies, Tomas Nilsson spoke on credence attributes for pork chops in the U.S. Jill Hobbs, University of Saskatchewan, provided two presentations; one on the implications of the adoption of trans-fat free Nexera canola and health care costs; the second on traceability in the Canadian food chain. Graduate student research in the Department of Rural Economy was highlighted through the presence of research posters. The symposium was well attended with approximately 100 people in attendance.

Rural Economy Facilities

The Rural Economy Reading Room continues to be a valuable resource for the department and is well-used by students. The scope of the collection includes, in addition to the traditional areas of agricultural and resource economics, forest economics and rural sociology, related material on agroforestry, environmental economics, and resource sociology.

The Rural Economy Graduate Computing Laboratory was expanded in 2003 to a 13 work station research facility. There are three types of workstations in the computing lab, designed for different types of work.

The most sophisticated machines in the lab are designed for computationally intensive operations such as number crunching with large data sets. These machines are dual processor, dual monitor machines with lots of memory and large hard disk drives. This allows students to work with very large data sets in an efficient manner without taxing network bandwidth. There are four of these in the lab. These machines also have the linux operating system installed for use by students who may need development tools and other packages that windows does not provide.

The next class of machines in the lab are high end workstations that are suitable for graphics manipulation and medium duty number crunching. They are single processor machines with a single monitor and large hard drives. There are five of these machines. The last types of machine available are a group of four lower end workstations that are used for general purpose email and word processing. These are the next machines scheduled for replacement.
