Prime Minister's Office

Prime Minister **Justin Trudeau** (Papineau, Que.) and the Premier of New Brunswick, **Blaine Higgs**, announced an agreement that will support an average of \$10–a–day child care in the province. Through the agreement, the governments of Canada and New Brunswick will work together to improve access to high-quality, affordable, flexible, and inclusive early learning and child care programs and services. This includes creating 3,400 new licensed early learning and child care spaces by the end of March 2026. With federal funding of almost \$492 million over the next five years, New Brunswick will also see a 50 per cent reduction in average parent fees for children under the age of six in regulated child care by the end of 2022. Public Health Agency of Canada

Dr. **Theresa Tam**, Canada's Chief Public Health Officer, issued a statement on COVID-19: "During the latest seven day period (Dec 3-9), an average of 3,450 new cases were reported, which is an increase of 22 per cent compared to the previous week. Currently, hospitalisation and critical care admission trends, which are lagging indicators, have levelled off, but if infection rates accelerate, trends could begin to rise again. The latest provincial and territorial data show that an average of 1,457 people with COVID-19 were being treated in Canadian hospitals each day during the most recent seven-day period (Dec 3-9), which is 5 per cent lower than last week. This includes, on average, 458 people who were being treated in intensive care units, 1.6 per cent less than last week and an average of 20 deaths were reported daily (Dec 3-9)." The report is an appeal to strengthen our public health system in Canada, in order to ensure we are better equipped against present and future health threats. COVID-19 has greatly tested public health systems in Canada and around the world. From the onset of the pandemic, Canada's public health system was thrust into the spotlight, as the first line of defense against the SARS-CoV-2 virus. As the pandemic has continued to unfold, we have witnessed our public health system rapidly adapt to meet the challenge of protecting the health of Canadians. It has risen to the occasion - but at a serious cost: our public health system is stretched dangerously thin and it is in need of critical reinforcements." Persistent criminalization of LGBTI status and ongoing violence and discrimination undermine the ability of LGBTI persons to fully participate in democratic and political processes." New Democratic Party of Canada

New Democrats called on Prime Minister **Justin Trudeau** (Papineau, Que.) to reverse the cut to the Guaranteed Income Supplement (GIS) that is making it difficult for working seniors to make ends meet. The NDP is urging the government to fix this cut in support for seniors before the end of the week when the House rises until January 31st. "The Liberal government stood by and said their hands were tied when the richest companies took pandemic support to pay bonuses to wealthy executives or to pay dividends to rich shareholders. Instead of making the wealthiest pay back the help they took and didn't need, the Liberal government is going after our country's poorest seniors and putting them in an impossible situation," said NDP Finance Critic **Daniel Blaikie** (Elmwood--Transcona, Man.). "Working seniors already struggle to make ends meet. Denying them the GIS, or severely reducing it, as a result of last year's emergency benefits is not only unfair but will make it impossible for some of them to make rent.
