SLIS Re-Accreditation Approved by ALA

SLIS underwent a lengthy re-accreditation process over the course of 2012-2013. The American Library Association accreditation process includes the production of a lengthy Program Presentation document, interviews and meetings with an External Review Panel.

LISAA executive participated in Accreditation Council consultations and by jointly organizing an alumni gathering at SLIS, which coincided with the visit of the External Review Panel.

Earlier this summer in a letter posted to the Jerome-L listserv Interim Director Ernie Ingles announced the successful re-accreditation of the program. While the work of many faculty,

The MLIS is Online

SLIS becomes the first library school in Canada to offer MLIS degree online

This year SLIS will welcome *two* new MLIS cohorts to its program: the regular on-campus cohort and the new online program cohort. Fifty new students from all over the world have enrolled in the new online MLIS program, and will sign on from countries as far-flung as Qatar, the Republic of Korea, Switzerland, and the United States to join their Canadian colleagues in earning an ALA-accredited MLIS degree. Using a variety of online tools, including eClass (Moodle) for asynchronous instruction and Adobe Connect for synchronous interviews and lectures with faculty, online students will receive the same well-rounded education expected from the MLIS program in a 100% online environment.

The program owes much to the leadership and passion of Ernie Ingles, former Director of SLIS. According to Acting Director Anna Altmann, Ernie is “a visionary with a long history of outreach to rural Canadians. The online MLIS is just one in a long line of projects that Ernie has spearheaded to make library resources and services, and now professional librarianship education, available to underserved citizens.”

SLIS associate professor and program coordinator Jennifer Branch will be teaching LIS 501 for the first cohort, and all SLIS faculty members have committed to teaching in the online program as it progresses. The class requirements are the same for the online degree: each student will take LIS 501-505 and two IT courses, and will complete their credit requirements with online elective options, which will be initially more limited than the array of options on-campus students have for their electives. The students accepted to the online program have demonstrated a commitment to community-focused librarianship, and the new program reflects this emphasis. Current online options include Collection Management, LIS Services in a

Culturally Diverse Society, and Multimedia Literacies. New courses are now under development which will be applicable to the needs and interests of both online and on-campus MLIS students, including Human-Information Interaction (which is offered for the first time on-campus this fall by assistant professor Tami Oliphant), Planning and Assessment, Library Governance, and Global Information Professions.

Nearly all of the students accepted in the online program work full-time, with more than half currently working in libraries. The online program model was designed with this in mind, and most students will follow the 2-2-1-1 model (two classes in fall and winter terms, and one class in spring and summer terms). Of the 2013 cohort, 42 students will follow this model, with eight opting to take one class each term. Students are required to complete the program within six years.

The program is designed for MLIS students only, and therefore is not open for CE credit or professional development. If you know of anyone who would like to take advantage of this flexible ALA-accredited degree program, applications are currently being accepted for the 2014 cohort. 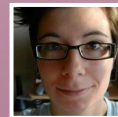

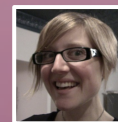
