- [Bill C-25](#), An Act to amend the Canada Business Corporations Act, the Canada Cooperatives Act, the Canada Not-for-profit Corporations Act, and the Competition Act, may continue to be debated at second reading Thursday;
- A Conservative private member's motion put forward by [Arnold Viersen](#) (Peace River-Westlock, Alta.) regarding Instruction to the Standing Committee on Health (violent and sexual online material) may be debated Monday;
- A deferred recorded division will be held on a Conservative Opposition motion put forward by [Blaine Calkins](#) (Red Deer-Lacombe, Alta.) regarding Preferential access to government Tuesday;
- A Liberal private member's motion put forward by [Deb Schulte](#) (King-Vaughan, Ont.) regarding Italian Heritage Month, may be debated Friday;
- And pending no substitutions in private member's business, bills [Bill C-309](#), [Bill C-301](#), and [Bill C-307](#) may be debated this week.

- [Bill C-6](#), An Act to amend the Citizenship Act and to make consequential amendments to another Act, may continue to be debated at second reading;

- [Bill S-229](#), An Act respecting underground infrastructure safety, may continue to be debated at second reading;
- [Bill S-227](#), An Act to amend the Customs Act (reporting requirements), may be debated at second reading.

Parliamentarians return to Ottawa this week and are expected to sit for five weeks, until December 16.

The government has four bills on the order paper this week. Bill C-26, Bill C-29, Bill C-25 are expected to be debated at second reading. Bill C-16 may be debated at report stage and Government House Leader [Bardish Chagger](#) (Waterloo, Ont.) hopes it will be read at third reading.
